March 9, 2020

The CCA Board of Directors met in the CCA Library for their regular monthly business meeting on Monday, March 9. The meeting began with the Opening Prayer given by Kathy Harrison. The meeting devotion was led by Josiah Town. Josiah's devotion was entitled "Focusing on Your Purpose" which included scripture from Philippians 1:22-25. Prayer requests were shared.

The minutes from February 10, 2020 were approved. The financial reports and bills from the month of February were reviewed and approved.

- Mrs. Ritchie reported to the board that several maintenance tasks were successfully completed in February: (1) Roof Repairs by Western Specialty; and (2) Breaker replacement in all three exterior breaker boxes by Contractor Tony Smith .
- Mr. Stevens reported that the CCA High School did receive A+ Designation from the Dept. of Elem. & Secondary Education, effective immediately! The A+ Scholarship Program is a definite blessing for our growing CCA High School.
- Enrollment Update was given. There are 133 students that have committed to enroll at CCA in grades K4-12 for the 2020-21 school year thus far. There are 12 other students pending enrollment. Praise God for the growth of this ministry opportunity as we begin planning for the new school year.
- Mrs. Ritchie updated the board with regard to staffing needs for the 2020-21 school year. Possible openings will be advertised and applications sought in the areas of HS math, preschool, special reading and grade 1.

BOARD ACTION

- The Board approved contracts for the 2020-21 school year. The administration recommended that the Board re-hire all current employees that indicated their willingness to return. Francis Mattlin, Rachel Guenther, and Kathy Brown will not be returning to CCA next year and will be greatly missed. Thanks to these very special ladies for their service to our CCA students!
- The Board approved clarification of the Athletic Eligibility Policy with regard to the evaluation periods due to the high school students that only receive semester grades in online Launch courses and dual credit courses. Revised wording: *“Evaluation periods for athletic eligibility will be mid-term (mid-quarter), at the end of quarters 1 and 3, and at the end of semesters 1 and 2. Mid-term and quarter grades for online and dual credit courses will be determined on CCA mid-term and end of quarter dates based on graded work at that time.”*
- The school calendar for the 2020-21 school year was approved.

CCA ALUMNI UPDATE

Mrs. Ritchie reported that a committee meeting was held at CCA on March 5 to plan for the CCA All School Reunion—20th Anniversary Celebration. Mark your calendars for Saturday, June 20.
