Clinton Christian Academy-Board Notes

May 11, 2020

The CCA Board of Directors met in the CCA Library for their regular monthly business meeting via Zoom on Monday, May 11. The meeting began with the Opening Prayer given by Allen Huff. Keith Carmichael shared scripture from Job 2 and James 1. Prayer requests were shared.

The minutes from April 15, April 23 & April 27 were approved. The financial reports and bills from the month of April were reviewed and approved.

- Mrs. Ritchie presented the resignation of Genia Miracle who is retiring from CCA after 15 years of employment as Financial Secretary. Mrs. Miracle will be greatly missed and we are thankful that she has agreed to help train her replacement next year!
- Mr. Stevens presented the HS schedule of courses for 2020-21. New courses include JRROTC, Spanish II, Algebra A, Job Shadowing, & Work Experience.
- Enrollment Update was given. There are 139 students that have indicated their intent to enroll for 2020-21.
- The Board authorized Mrs. Ritchie to proceed with bids for proposals to address cleaning the carpets and waxing to be completed over the summer.
- The Board authorized Mrs. Ritchie to seek bids for proposals to address the HVAC needs in the Band/Music Rooms.
- Mr. Stevens and Mrs. Ritchie reviewed the proposed changes to the 2020-21 Student Handbook. The Board will give final approval after a second reading in June.

BOARD ACTION

- The Board approved the administration's recommendation for establishing guidelines to weight the grades of more challenging high school courses in order to give students enrolled in higher-level courses (such as honors courses, advanced placement courses, dual credit courses, etc.) a numerical advantage when determining relative academic performance and related honors such as honor roll or class rank. A two-tiered system of weighted grading (.5 grade points and .333 grade points) will be awarded retroactively to all high school students enrolled in upper level high school courses as outlined in the new policy.
- The Board approved awarding a teaching contract to Heidi Foreman for two high school English classes in 2020-21.
- The Board accepted the resignation of Ashleigh Harrison and released her from her 2020-21 contract. Best wishes to the Harrison's as they seek God's direction for their family!
- The Board approved the purchase of 20 additional lockers for the Upper School.
- The Board set a tentative HS Graduation Date of June 20 and 8th Grade Promotion Date of June 25 with specific details to be determined.
