# Clinton Christian Academy Board Notes

January 11, 2021

The CCA Board of Directors met in the CCA Art Room for their regular monthly business meeting on Monday, January 11. The meeting began with the Opening Prayer given by Keith Carmichael. Kathy Harrison shared the devotion which included scripture from Exodus 40. Prayer requests were shared. The minutes from December 14 were approved. The financial reports and bills from the month of December were reviewed and approved. The Board welcomed Kristy Bateman, Parent Rep, who attended her first board meeting this month! So thankful for your service as a board member at CCA!

- Mrs. Ritchie updated the Board with current enrollment which is at 131. There have been several inquiries about new enrollment at the semester, so it is possible that we will have a few new families joining our CCA in the next few weeks.
- The Board reviewed the presentation that will be shared with parents at the annual **Re-enrollment Parent Meeting is scheduled for Tuesday, Jan. 25 @ 6:00 in the CCA Gym.** This important meeting will be led by Dain Sisk, Allen Huff and the CCA Administration. Topics of discussion will include a financial review and tuition rates for the 2021-22 school year. Enrollment forms will be distributed to families at this meeting and will be due back by February 1.
- The Board is reviewing Administrator and Teacher Contract Language for the 2021-22 School year. ACSI's recommended contract language is being utilized, along with our current contract language, to revise the contracts that will be utilized next year.

## BOARD ACTION IN DECEMBER

- The Board approved having a new school credit card issued with a limit of \$3000 in Melanie Dehn's name as our new Financial Secretary.
- The Board approved acceptance of a property donation to CCA from Josiah and Chelsea Town. CCA is thankful for our community support.

## BOARD TOPICS OF DISCUSSION FOR FEBRUARY

- ✓ Mrs. Ritchie and the Board continued their discussion about improving internet access and speed at CCA. Negotiations with United Global Systems for a commercial hotspot are at a standstill as the company researches available options that might work in our metal building. Mr. Stevens and Mrs. Ritchie will be visiting with other companies locally to see if there are any other internet options. Mrs. Ritchie will also be contacting an individual to help explore the E-rate Program which provides discounts to assist eligible schools to obtain affordable internet access and supports connectivity. It is the goal of the Board to have a solid plan of action for improved internet services in the next 90 days.
- ✓ COVID protocol was reviewed and discussed. **Morning temperature screening will be eliminated beginning Tuesday, January 19.** No fevers have been identified during the morning temp check due to the terrific job parents are doing checking temperatures and screening their child(ren) for COVID symptoms. Temperatures will continue to be checked as needed throughout the school day. All other COVID protocol will remain in effect.
