March 8, 2021

The CCA Board of Directors met in the CCA Art Room for their regular monthly business meeting on Monday, March 8. The meeting began with the Opening Prayer given by Jeff Lowe. Jeff Lowe gave this month's devotion with the focus of this presentation related to "Eternal Investment" as the primary mission of our CCA Family. Prayer requests were shared. The minutes from February 15 were approved. The financial reports and bills from the month of February were reviewed and approved.

- Jeff Lowe shared an auction update with praises to God for a record high in this fund-raising event totaling approximately \$140,000. The Board would like to extend its thanks for all of the help and support given by CCA Families! What a mighty God we serve!
- The Board discussed its annual Board Self-Assessment compilation. Areas of improvement targeted as result of this assessment included more professional development for the members of the Board and an annual Safety Inspection to be completed each June. Improvement of salaries and benefits was also an area that the Board identified as well.
- Mr. Stevens updated the Board with regard to Rocket Connect's progress with installation of the hardware for our new internet as well as installation of the updated wi-fi equipment. Included in Mr. Stevens' review was a general overview of CCA's information technology.
- The Board continued its discussion regarding candidates for consideration in filling positions that will be needed in the near future on the CCA Board of Directors as current members' terms expire.

BOARD ACTION IN MARCH

- **The Board approved new administrator and teacher contract language after a third reading, which will be used for the 2021-22 school year. This new language was a combination of recommendations from ACSI and language used from current contracts.**
- **The Board approved hiring staff for the 2021-22 school year. Contracts will be going out to the staff in the next couple of weeks.**
- **The Board approved making masks optional for grades K4-2 beginning on March 29. The Board felt continuing to wear masks until the March 29 date for all students an important one due to Grandparent's Tea scheduled for elementary grades K4-6 on March 25 & 26. Grades 3-12 will continue wearing masks until further information from the most current research may be gathered in order to determine the wisest course of action for students/staff in these grade levels.**
