Clinton Christian Academy Board Notes

April 15, 2021

The CCA Board of Directors met in the CCA Art Room for their regular monthly business meeting on Monday, April 12. The meeting began with the Opening Prayer given by David Stevens. Keith Carmichael gave this month's devotion with the focus of this presentation related to CCA's focus upon the importance of "prayer". Scripture from Matthew 18:3 was included in the devotion. Prayer requests were shared. The minutes from March 8 and March 25 were approved. The financial reports and bills from the month of March were reviewed and approved.

- Current enrollment for next year was shared with the board. Projections for enrollment are currently at 141 students in grades K4-12
- Mrs. Ritchie reported that Grandparent's Tea and the Book Fair (March 22-26) were very successful with around 185 grandparents visiting grades K4-6. Each class presented a special program in the cafeteria, followed by refreshments and a visit to the Book Fair in the CCA gym. Total book sales were \$4000 with around \$2500 of that amount coming back to the school for the purchase of scholastic books for our library. Thanks to Jenny Bradley and all of her helpers for another great book fair!
- Special thanks to Logan's Heating & Air/Lennox's sponsorship of some playground improvements in the amount of \$4000. These improvements will be made this summer—so stay tuned for more details coming soon!
- Mrs. Ritchie gave an update regarding open positions for the 2021-22 school year: Upper School Principal; HS Band (Mr. Helmig will not be returning); Parttime office position; and para positions (number needed to be determined as enrollment/schedules are finalized).

BOARD ACTION IN APRIL

The Board approved moving Mrs. Shauna Townsend to a full-time teaching position. Mrs. Townsend will be teaching elementary vocal music, band, publications, computers, library, and speech for 7^{th} and 8^{th} grades next year.

Board Approves Academic Lettering Award for HS Students

Students in grades 9-12 will have the opportunity beginning this school year to earn academic recognition with the program guidelines approved at this month's Board meeting. Students must meet or exceed the following criterion for this new award:

- 1. Students must be enrolled full-time at CCA for two full semesters.
- 2. Students must maintain a cumulative GPA of 3.25 or better with no semester grade below a C- no matter the GPA; or a student may receive an academic letter with a year-end GPA of 3.5 or better.
- 3. Students must have 10 documented hours of community service.

The first time a student "letters" he/she will receive a letter with a lamp of learning insignia and a bar. A bar will be awarded for each subsequent year for which the student meets eligibility criterion. Letters and bars will be awarded at the end of the year awards assembly.

For the 2021-22 school year the 10 hours of community service will be waived and only GPA criterion will be used for this award. All criterion listed above will be in effect beginning with the 2021-22 school year.
