Clinton Christian Academy Board Notes

October 13, 2025

The CCA Board of Directors met in the CCA Art Room for their regular monthly business meeting on Monday, October 13. The meeting began with the opening prayer given by Barry Bullock. David Mills shared a devotion on 1 Thessalonians 5:11, highlighting the vital role of encouragement in the Christian life and in the Board's work. He emphasized that encouragement fosters unity, builds trust, and strengthens collaboration. When offered in truth and love, it reflects Jesus' example, inspires confidence, and supports wise, God-honoring decisions.

The financial reports and bills from the month of September were reviewed and approved. Prayer requests were shared.

- 1. Mrs. Ritchie reported that the final section of the playground surfacing is complete. The new pour-in-place surface improves safety, accessibility, and drainage. Final payment has been made; reimbursement paperwork is pending. This significant improvement was made possible through grants and persistence over five years.
- 2. Mrs. Jones provided an update the Board about Pink Out. The Lady Patriots Volleyball team hosted a Pink Out event on Oct. 6 to support breast cancer awareness, raising over \$1,000 for the Pogue family. The night included games, raffles, and prayer, reflecting CCA's commitment to service and compassion.
- 3. The administration reported that the first auction meeting took place Oct. 7 with strong attendance. Key updates include earlier auction date, hybrid format (mostly online with 10 live items), return of dinner, and increased student involvement. Families are encouraged to contribute through time, donations, and talents.
- 4. Mrs. Hyke reported that the student-led Bible studies continue monthly for grades 7–12, with senior students now visiting classrooms for prayer and mentorship. These initiatives aim to deepen spiritual growth and foster community across grade levels.

BOARD ACTION & DISCUSSION IN OCT.

- ➤ The Board had a second read of two proposed policies: (1) Anti-Bullying Policy; (2) Mandated Reporting Policy. Both policies were approved as presented.
- > The Board also had a second read of the Computer Usage Agreement for Staff. This document was also approved and will be presented to staff annually each school year for review.
- The Board accepted the resignation of Kim Watson.
- Mrs. Hyke shared that the focus of this year's Senior Trip remains mission-minded, with the primary purpose of spreading the Gospel, while also incorporating fun activities. The destination and itinerary have not yet been finalized. Students are presented with several location options to research, discuss, and reach consensus. Once a preferred location is selected, Mrs. Hyke contacts each senior parent individually to confirm their comfort with the choice. A final itinerary is then developed, blending mission opportunities with recreational experiences. Mrs. Hyke serves as trip sponsor, accompanied by at least one additional parent chaperone. All senior parents are invited to attend.
